11/2/20 – 12/31/20: The Saputo Cheese USA Inc. **FRIGO® CHEESE “LOTTA RICOTTA INSTANT WIN GAME & SWEEPSTAKES”** starts at 12:00:01 AM Eastern Time (“ET”) on **November 2, 2020** and ends at 11:59:59 PM ET on **December 31, 2020** (the “**Entry Period**”). The promotion consists of a sweepstakes (“**Sweepstakes**”) and an instant win game (“**Instant Win Game**”), and together with the Sweepstakes, the “**Promotion**”).

ELIGIBILITY: The Promotion is open to all legal US residents physically residing in the 50 United States and District of Columbia who are 18 years of age or older, as of the date of entry, and have reached the age of majority in the state of residence. Employees and their immediate family members (parents, children, siblings or spouse, regardless of where they live and persons living in same household, whether related or not) of Saputo Cheese USA Inc. (the “**Sponsor**”), Southern Made Services, LLC (the “**Administrator**”), Hangar12, their respective subsidiaries and affiliated companies and any other entities directly associated with this Promotion are not eligible to participate, enter or win. Void in Puerto Rico, U.S. territories, U.S. military installations in foreign countries, and where prohibited or restricted by law. Winning a prize is contingent upon compliance with these Official Rules (“**Official Rules**”) and fulfilling all requirements set forth below.

Entries from anyone who has been a prize winner in any contest or sweepstakes sponsored by the Sponsor in the twelve (12) months prior to the Sweepstakes start date are not eligible to win.

A thank you message will be displayed to confirm that your Entry Form was successfully recorded. After completing the Entry Form or logging on (for returning participants), you must then follow the on-screen instructions to vote for a favorite Frigo®

Cheese Ricotta to play the Instant Win Game (“**Game Play**”). After the Game Play, you will receive notification on the Website screen as to whether he/she is a potential “Instant Winner” (“**Notification**”).
